IL State Treasurer Surprises Special Olympics Athletes with USA Games Reveal

IL ABLE Program Helps Illinois Athletes Compete in Orlando Next June

9/17/21 – Pontiac, IL – On Thursday, September 16, Illinois State Treasurer Michael Frerichs visited Special Olympics Illinois athletes Brandy Stowers and Brian Antczak, who compete with Team AIR Pontiac in Pontiac, IL. During his surprise visit, Treasurer Frerichs revealed to the two athletes that they would be a part of Team Illinois, a group of athletes, coaches, and Unified Partners that will represent Special Olympics Illinois at the 2022 Special Olympics USA Games next June in Orlando, FL.

Brandy and Brian also learned that the IL ABLE Program will help sponsor the cost of Illinois athletes to participate in the USA Games. Special Olympics Illinois does not charge athletes to compete in the USA Games events, so Special Olympics Illinois relies on funding from individuals and organizations to make it possible for Illinois Special Olympics athletes to attend.

Through its support of this event, the IL ABLE Program hopes to make all Special Olympics athletes and their families aware of the benefits of having an IL ABLE account for people with disabilities. IL ABLE accounts are savings and investment accounts that eligible people with disabilities and their families can open to help themselves by building greater financial independence and improved quality of life while preserving benefits.

"Before the IL ABLE Program, families with loved ones with disabilities were discouraged and penalized for saving and investing," Treasurer Frerichs said. "The Illinois Treasurer's office is proud to have started IL ABLE so that eligible Illinoisans with disabilities, including many Special Olympics athletes, can improve their financial independence, health and quality of life."

Twenty-five-year-old Brandy has been competing with Special Olympics for ten years. She enjoys walks and video games and, when she's not competing, she works at Accolade and resides in a group home. Brian, 42, has been competing with Special Olympics for 15 years. He works at Stroller International and has previously enjoyed traveling to Florida to visit family.

The 2022 Special Olympics USA Games is scheduled for June 5-12, 2022 in Orlando, Florida. Jersey Mike's Subs is the Presenting Partner and the Games are hosted by Disney. During this magical week, more than 5,500 athletes and coaches from all 50 states and the Caribbean will travel to Florida to unite in one of the country's most cherished sporting events. ABOUT THE ILLINOIS TREASURER:

As Illinois State Treasurer, Michael Frerichs is the state's Chief Investment and Banking Officer and actively manages approximately \$52 billion. The portfolio includes \$27 billion in state funds, \$16 billion in retirement and college savings plans and \$9 billion on behalf of local and state governments. Frerichs' office protects consumers by safeguarding more than \$3.5 billion in unclaimed property, encouraging savings plans for college or trade school, increasing financial education among all ages, assisting people with disabilities save without losing government benefits, and removing barriers to a secure retirement. Ascensus College Savings Recordkeeping Services, LLC, the Program Manager, and its affiliates, have overall responsibility for the day-to-day operations, including investment advisory, recordkeeping and administrative services.
